Pope Francis to COP28
Climate Conference, World
Religions: Unite Against
Environmental Devastation
Despite intentions to be
present at the COP28
climate conference in Dubai,
Pope Francis's words were
shared with the conference,
and during the opening of

the Faith Pavilion, a first for a COP gathering, saying it is essential for all world religions to unite in opposing the "rapacious" devastation of the environment. The 86-year-old pope planned to preside at the opening of the Faith Pavilion, but had to stay at the Vatican due to a lung inflammation. Secretary of State Cardinal Pietro Parolin read the pope's messages. The following excerpt is from a Reuters article.

"Religions, as voices of conscience for humanity, remind us that we are finite creatures, possessed of a need for the infinite,' the Pope said, noting that a Faith Pavilion was a first at a COP conference. 'For we are indeed mortal, we

have our limits, and protecting life also entails opposing the rapacious illusion of omnipotence that is devastating our planet,' he said.

Religions, he said, 'need, urgently, to act for the sake of the environment', educate their members to 'sober and fraternal lifestyles' instead of wasteful ones and work for a return to the individual contemplation of nature's grandeur.

'This is an essential obligation for religions, which are called to teach contemplation, since creation is not only an ecosystem to preserve, but also a gift to embrace,' Francis said."

## National Interfaith Power & Light at COP 28

National Interfaith Power & Light has a strong contingent of IPL representatives in Dubai for the COP28 climate conference, including IPL President Rev. Susan

Hendershot who is sharing regular blogs about her experiences, especially as relates to the urgency with which communities of faith view the climate crisis and calls for urgent action. See the link below for her blog posts.

IPL recently collected 4,000 signatures of people of faith and conscience on a letter to President Biden and the State Department urging greater ambition by the U.S. Government at COP28. IPL and partners delivered the letter in person to Trigg Talley, Senior Advisor to the Special Presidential Envoy for Climate and Director of U.S. Climate Negotiations at COP28. "In the letter, we not only urge the U.S. to increase ambition but to support increased climate investments in the Green Climate Fund, to support the Loss and Damage Fund (which was established on Day One of the summit), and to prioritize climate justice and a just transition off of fossil fuels. In his remarks to our group, Mr. Talley said that the faith voice is crucial in these climate talks, as

our advocacy at home is what allows their team to effectively do their work at COP. The U.S. is unable to make commitments to the global community that cannot be delivered on at home," said Rev. Hendershot. For example, while the \$17.5 million pledged to the Loss and Damage Fund has already been allocated through Congress, the \$3 billion pledge made to the Green Climate Fund faces opposition at home.

"We have been talking with members of the Biden Administration, U.S. governors, mayors, and state legislators, speaking at the Faith Pavilion about fossil-free places of worship, meeting with faith and secular partners to strengthen coalitions, and learning about climate impacts from our global siblings experiencing first-hand devastation to communities and cultures." <a href="IPL Blogs">IPL Blogs</a>.

#### VTIPL Retreat & 2024 Plans. Savethe date for Faith Climate Action Lobby Day, Feb. 28

In late October, VTIPL's Board of Directors gathered at All Souls Interfaith Gathering's gorgeous location in Shelburne overlooking Lake Champlain to reflect on the past year's work and to chart plans for 2024. While considering a lengthy list

of projects, in-person and virtual events, activities, and partnerships, we share news of two of VTIPL's signature activities on which we're already focusing.

Save-the-date for Faith Climate Action Lobby Day, on February 28, 2024. VTIPL will again participate in a Faith Climate Action Day of activities at the Statehouse in Montpelier. Please plan to join us if you can when we will reiterate to our state legislators that communities and people of faith and conscience demand action now to address the urgent climate crisis. In 2023, we held our second Faith Climate Action Day, after a first event in February 2020. The COVID-19 pandemic prevented us from making it an annual lobby day. Faith Climate Action Day is a collaboration with our partner organizations Vermont Interfaith Action (VIA) which has recently identified climate as a priority issue for the organization, Vermont Public Interest Research Group (VPIRG), Vermont Conservation Voters, and others.

Stay tuned for news about an in-person Celebrating Sacred Waters gathering later next year. During our recent Rock Point-based Equinox Lament and Celebration of Earth, a main comment from participants was how valuable it is to actually BE together, especially coming together in the natural world that we cherish and are dedicated to protecting. Celebrating Sacred Waters is an answer to that call. We also hope to have other in-person gatherings routinely and outdoors as possible and appropriate. We need each other, and we need the inspiration and community of nature and our sacred Mother Earth.

#### **Climate Action Update - Opposition to McNeil District Heating Project**

Rev. Kim Hornung-Marcy is leading efforts among Burlington-area faith communities to oppose the construction of a \$40 million project to deliver steam produced by the McNeil wood-fired power plant in Burlington to replace steam produced by the UVM Hospital's natural gas fueled boilers. Opponents want the McNeil plant closed as soon as possible because wood fuel combustion produces large amounts of carbon dioxide and fine particulate pollution, exacerbating the climate crisis.

In October, the Burlington City Council voted to proceed with the McNeil project even in the face of strong opposition. A coalition continues efforts to halt this project. VTIPL acknowledges that this is a complex conversation, yet we appreciate all efforts to reduce fossil fuel emissions. For more information and/or to get involved, contact Rev. Hornung-Marcy



# IPL Cool Congregations Challenge Deadline, December 15

There is one week left for congregations to apply for

a chance to win \$1,000 in the Cool Congregations Challenge. It's also a great opportunity to be recognized for efforts to become climate leaders. National IPL encourages all congregations to consider applying for the contest. Is your congregation planning to take advantage of new federal funding available for nonprofits to upgrade facilities to reduce energy use? If you have plans for energy audits, written action plans, and fundraising, apply for the Cool Planner category. There are six categories; in each, the winner receives \$1,000 while three runners-up receive \$500:

- •Energy Saver: lighting, insulation, windows & doors, heating & cooling systems
- •Renewable Role Model: solar, wind, geothermal, solar water heating
- •Sacred Grounds: native landscaping, organic gardening, water conservation, bike racks, wildlife habitats, composting
- •Community Inspiration: inspire congregants to reduce at home, help

communities transition from fossil fuels to clean energy & prepare for impacts of climate change

- •Cool Congregations Planner: audits, planning reports, fundraising
- •Electric Vehicle Leader: EVs, charging stations, education, advocacy, outreach.

Projects can take place inside worship spaces or other buildings, on grounds, in congregants' homes, or in the community. Eligibility includes projects completed in 2021, 2022, and 2023. Congregations which previously applied but did not win are eligible to apply again for projects completed in those three years. In the last Challenge, South Burlington's Ascension Lutheran Church was a Cool Congregations winner. Read more on <a href="VTIPL's website">VTIPL's website</a>. #### **Vermont Community EV Chargers Program Open to Non-profits**

Help grow electric vehicle chargers and electric transportation across Vermont. Non-profit organizations, such as congregations, are now eligible for grants from the Department of Housing and Community Development to help cover most, if not all, of the cost to install Electric Vehicle chargers. Complete the pre-application to the best of your ability; help is available for technical and financial assistance. The grant is open to applicants from all of Vermont. Requirements for applicant matching funding amounts are as follows:

- -Nonprofits require a 5% applicant match meaning the grant pays an incredible 95% of the cost. For example, the cost to Ascension Lutheran for charging equipment and installation brought the quoted cost down from \$30,000 to less than \$2,000;
- -For-profit organizations need a 10% applicant match;
- -Women and minority-owned organizations are exempt from matching fund requirements. <u>Email</u> or call 802-655-8722.

#### **Preservation Trust of Vermont Grants, Deadline December 21**

The Preservation Trust announces the 2024 Paul Bruhn Historic Revitalization grant round. Awards of \$50,000-\$100,000 will be made to preserve and rehabilitate community gathering spaces of economic and social significance in rural communities. Of particular interest are projects aiming to increase the economic vitality of a community or that bring new economic and community activity to village centers. A total of \$625,000 will be awarded to nonprofits and municipalities in towns with populations less than 7,500 people. The Trust also announces new eligibility criteria in 2024 for privately-owned commercial and mixed-use buildings in Designated Downtowns or Village Centers in communities with a population of less than 7,500 people. Many of us enjoy listening to On Being interviews with Krista Tippett. Of all those I've heard over the years, this one stood out. Maybe it's because I'm a longtime environmental activist like her guest, the extraordinary climate leader Christiana Figueres, whose father was president of Costa Rica and prompted the country to disband its army. But more so, I think it's because Figueres offers us hope at a time of such profound ecological crisis while connecting it to her, and our, spiritual life. Here's the program description: "The ecological crisis we are standing before is at once civilizational and personal - intimately close to each of us in the places we love and inhabit, and unfolding at a species level. And as much as anyone alive on the planet now, Christiana Figueres has felt the overwhelm of this and stepped into service. She gives voice so eloquently to the grief that we feel and must allow to bind us to each other — and what she sees as a spiritual evolution the natural world is calling us to. If you have wondered how to keep hope alive amidst a thousand reasons to despair, if you are ready to take your despair as fuel — intrigued by the idea of stepping into love and immediate realities of abundance and regeneration — this conversation is for you."

Having been an environmental activist and educator for 3+ decades, I must continue working on the climate crisis, or as my Irish writing mentor says, the "climate catastrophe".
